

Accenture Explorer Mobile Application Privacy Statement

This privacy statement is effective 15th July 2020

This privacy statement explains how Accenture collects and uses the data of users of the application (Accenture Explorer) a mobile device. This privacy statement may be updated regularly and changes will be reflected in this App. Users are recommended to check regularly the Privacy Policy link in the app and app store (i.e. Apple App Store, Google Play, and/or Windows Store). For any change in the purposes of the processing, the renewed consent of the users shall be procured.

Accenture is processing your personal data for the following purposes

Accenture Explorer provides meeting and logistics information to clients who are scheduled to visit an Accenture location. Visit details, meeting agendas and pre-read materials, facility access and Accenture insights on infrastructure services, business process outsourcing, and application services all in one place to ensure an insightful client visit. It serves as a platform of communication between all stakeholders during business meetings.

What information does the App collect and how is it used?

Accenture collects information via Apps in two ways: (1) directly (for example, when you provide information to log into the App or complete a form within the App), and (2) indirectly (for example through mobile analytic technology).

We may collect and process the following information

- **Email ID**
- **Mobile App Username (Email ID) & Password (Accenture Explorer App Generated)**
- **Current Location**
- **Phone Number**
- **Photos**

Automatically Collected Information – The App may collect certain information automatically, such as the type of mobile device you use, the mobile operating system, the amount of time you spend in the App, and information about the way you use the App. This App may also use certain analytics software that enables Accenture to better understand the functionality used in the App so that Accenture can continue to improve the App. For the app to stop collecting your information just opt-out of data collection in App Settings section or **by uninstalling the App**. To uninstall the App you should use the standard uninstall process of your mobile device. However, please note Accenture will retain any previous usage information collected from the App according to with the retention section of this Privacy Statement.

Additional functionality enabled

For those consumers that have consented to the installation of any apps and any updates that are released through the app store, you further understand and agree that the App (including any updates) may (i) cause your device to automatically communicate with Accenture or third-party servers to deliver the functionality described regarding the App and/or record usage data and metrics, (ii) view, affect or modify preferences or data stored on your device, (iii) collect personal information to provide the features described above and as set out in this privacy policy, (iv) read the contents of your USB storage and phone status and identity to, and (v) view network and Wi-Fi connections.

Information provided by you – The App may collect information that you voluntarily provide, for example when you register to use the App using a username and password (if applicable) or when completing a survey or requesting information.

We use this information to provide you with the services you request and for other purposes which we would describe to you at the point where your information is collected. For example:

- To fulfill your requests for content
- For surveys or research questionnaires
- To personalize your experience in our App
- To determine what is effective about our App, how it is used by users and how we might improve it

Such information collected by this App will be collected and used in accordance with the terms of this privacy statement, the [Accenture Privacy Statement](#), applicable data privacy laws and Accenture’s internal policies.

Does the App collect precise real-time location information of the device?

This App may collect information about the location of your device if a user opts-in to provide such information. If location information is collected, we use your location information to measure the geographic performance of the App and to continue to improve and expand the content we provide, based on geographic location of our end users.

Cookies and other tracking technology

How long do you keep my information?

We will retain the data for as long as you use the App and for a reasonable time thereafter. Please note that some or all of the data may be required for the App to function properly, and we may be required to retain certain information by law.

Where will my information be processed?

As a global organization with global IT systems, personal data we collect may be routed, stored, or transferred internationally throughout Accenture’s worldwide organization or our vendors. We have internal policies in place to ensure an equivalent level of protection is in place across our organization. We may also share personal data with our contracted service providers and advisors who may be located globally and so we may need to transfer your personal data to other countries. Before we do so, we take steps to ensure that your personal data will be given adequate protection as required by relevant data protection laws and Accenture’s internal policies.

Security

We take appropriate steps to maintain the security of personal data collected via the App. Our App may, from time to time, contain links to and from the sites of our partner networks, advertisers, and affiliates. If you follow a link to any of these sites, please note that these sites have their privacy policies and that we do not accept any responsibility or liability for these policies or sites.
